FAMILIARISATION PROGRAMME FOR INDEPENDENT DIRECTORS

- 5. Products manufactured by the Company and the facilities available, including the location of the plants and their respective facilities and capacities.
- 6. Market for the product and the industry scenario.
- 7. Details of financial position and assets and liabilities.
- 8. Share capital, listing with stock exchanges and status of compliances.

In case the Independent Director is desirous of making factory visits, he will be taken to factories. Otherwise at least one Board Meeting of the Company will be held at the factory site to enable the Directors to have hands on information/knowledge on the operations of the Company.
